

What's New?

easi to become easiest

CDSL's much awaited internet facility "electronic access to securities information & execution of secure transactions" - (easiest) is being launched on March 9, 2004. The easiest facility will be inaugurated by Shri G N Bajpai, Chairman, SEBI. easiest will establish a common platform for BOs for issuance of delivery instructions through the internet. The "easiest" facility will provide an anytime anywhere kind of freedom to investors to issue delivery instructions. Besides enabling them to meet the strict deadlines of delivery set under the T+2 regime, it will also obviate the need of their visiting DP offices to give debit instructions.

Certification Programme on Depository Module - BCCD

CDSL in association with the BSE Training Institute (BTI), is launching a certification programme on depository module titled "BSE's Certification on Central Depository (BCCD)" on March 9, 2004, at the hands of Shri G N Bajpai, Chairman, SEBI. All registrations for the BCCD programme will be handled by BTI. The certification test will be conducted online by BTI, which has tied up with various centers of Zee Interactive Learning Systems Ltd. (ZILS). On successful completion of the test, the BCCD certificate will be issued by BTI.

In order to register for this program, the BCCD registration form should be downloaded from CDSL's website www.cdslindia.com or from www.bseindia.com. The duly completed registration form alongwith four passport size photographs and a certification fee of Rs. 750/- (Seven hundred and fifty only), payable through demand draft in favour of "The Stock Exchange, Mumbai", should be forwarded to BSE Training Institute, 21st floor, P. How to write your CDSL demat account number in public issue forms :

While subscribing to a Public Issue (IPO), an accountholder is required to mention his demat account number in the IPO application form, if he desires to obtain credit of allotted securities in the dematerialised form. It is observed that in some cases, the IPO application form contains a 16-block format for filling in the CDSL demat account number. However, in case of some others, separate blocks are provided in the application form for giving details of DP-Id and Client-Id, thereby creating some confusion in the minds of the investor.

While mentioning the CDSL demat account number in the IPO application forms (in cases where separate blocks for giving details of DP-Id and client IDs are provided), the demat account number can be written in the following manner:

DP ID <First 8 digits of the 16 digit BO ID>
Client ID <Next 8 digits of the 16 digit BO ID>

E.g. If the demat account number is 13025800 00001234, the same can be written in the following manner on the IPO application form—

DP ID 13025800 Client ID 00001234

Withdrawal of Transfer-Cum-Demat Scheme

SEBI has vide its circular ref. no. SEBI/MRD/Cir-10/2004 dated February 10, 2004 informed that the facility of transfer-cum-demat is withdrawn with immediate effect. Investors/Issuers/RTAs are requested to take note of the same and not to send any transfer cum demat option letters to DPs.

easiest - electronic access to securities information and execution of secured transactions

1. What is easiest?

easiest is a internet facility which permits Brokers(CMs) / Beneficial Owners(BOs) to submit debit / credit transaction instructions to effect off-market, onmarket, inter-depository and early pay-in transactions. Moreover, all the facilities and benefits of easi are automatically available to a subscriber of easiest.

2. Why should I subscribe /register for the easiest facility?

A BO/CM should register for easiest as it gives an anytime-anywhere freedom for submission of debit / credit transaction instructions and access to demat account details of holdings and transactions. Thus, a BO does not require to approach his DP each time a transaction instruction is to be submitted.

3. Does the BOs/ CMs have to submit physical instructions slips to the DPs?

No, BOs/ CMs who have entered instructions through easiest do not have to give a separate debit instruction slip to their DPs.

4. Can all BOs /CMs use the easiest facility?

Yes, the easiest facility is available to all BOs and CMs. However, A BO/CM can avail of easiest facility only if the DP with whom he maintains his account is registered for this facility.

5. How do I register for easiest?

- a. Login to CDSL's website www.cdslindia.com.
- b. Click on the link "Register Online" from the Home page.
- c. Select the facility (easiest) you wish to register for.
- d. Enter your details like login -Id, Email-Id, etc.
- e. Print the registration form.
- f. Submit the registration form to your DP duly signed by all account holders.
- g. You will then receive the password at your email-Id.
- You can commence using "easiest" by entering the "User name" and "Password" at the homepage of CDSLs site www.cdslindia.com

6. If I am registered for easiest, will I able to use the facilities being offered under easi?

Yes-all the facilities of easi will be available to all registered users of easiest.

7. If I am registered to easi will I automatically be able to use easiest?

No, you shall be required to register for easiest separately. A BO can, however, use the same easi login for easiest.

8. What are the different options for giving transaction instructions on easiest?

There are two options available on easiest:

Trusted account - Transfers

- Trusted accounts are those accounts known to you and must necessarily be a settlement accounts of your CM, through which you buy / sell securities on stock exchanges.
- If this option is selected, transfer of securities will be permitted to a maximum of 4 trusted CDSL CM accounts.
- Setting up of transactions through trusted account option will be permitted by additional password (PIN), which will be mailed separately.
- The following transactions will be permitted under the 'Trusted Account' option:
 - i. Off-market transfer to designated CM accounts.
 - ii. On-market transfer where CM-ID of the designated CM accounts ismentioned

Account of choice

- In the 'Account of Choice' option, transfer of securities will be permitted to any account using a digital signature stored on e-token (device provided by CDSL, which stores the digital signature).
- CMs will have "Account of choice" option only and must procure e-token for authenticating transactions.
