



What's New?

New Features in Inter Depository Module

The facility of online Inter depository transfers (IDT) was made operational on December 14, 2002. The IDT facility has provided great convenience to users, as it enables seamless transfer of securities between the depositories at any time during specified business hours. CDSL has recently introduced additional features in the Inter-Depository Module, which will enable a BO to obtain the actual time of Debit / Credit of an Inter-Depository Transaction, thereby increasing operational convenience to DPs.

Dematerialisation of Warehouse Receipts

CDSL is pleased to inform that it has tied up with "National Commodity and Derivatives Exchange" (NCDEX) for providing the facility of maintaining warehouse receipts in dematerialized form. NCDEX has empanelled the following DPs for opening of accounts for holding warehouse receipts in electronic form –

1. Bank of India
2. HDFC Bank
3. ICICI Bank
4. IL & FS Limited
5. Karvy Consultants Limited
6. Oriental Bank of Commerce
7. Stock Holding Corporation of India Limited
8. UTI Bank

The legal status of warehouse receipts being different from that of securities, BOs or CMs are required to open separate demat accounts for holding warehouse receipts and such accounts can be used for holding only electronic warehouse receipts. The procedure for opening of accounts for holding electronic warehouse receipts would be the same as followed for opening of accounts for holding securities. However, persons wishing to open such accounts should execute a separate agreement with their DPs.

Suspension of Certificate of Registration of M/s Sindhu Corporate Services Limited

The Securities & Exchange Board of India (SEBI) has passed an order on June 18, 2004 suspending the certificate of registration granted to M/s. Sindhu Corporate Services Limited, Registrar & Transfer Agent (INR000001732) **for a period of three months i.e. from July 10, 2004 to October 9, 2004**. In view of the above, the said

Registrar will not be entitled to carry on the business as a Registrar and Transfer Agent from July 10, 2004 to October 9, 2004. BOs are advised not to forward any dematerialization requests for those companies where the RTA agent is Sindhu Corporate Services Limited, till such time the issuer company makes alternative arrangements.

CM Investor Securities Account (CISA)

SEBI vide its circular no. MRD/DoP/SE/Dep/Cir-30/2004 dated August 24, 2004 has emphasized the need for CMs to transfer securities from their pool accounts to the respective beneficiary account of their clients within 1 working day after the payout day. The securities lying in the pool account beyond the stipulated 1 day period shall attract a penalty at the rate of 6 basis point per week on the value of securities.

Electronic Transaction Statements to BOs

SEBI has vide its circular no. MRD/DoP/Dep/Cir-27/2004 dated August 16, 2004 has permitted DPs to replace the hard copy of transaction statements by electronic statements. As per the circular, DPs have been permitted to provide transaction statements to the BOs under Digital signature, as governed under the Information Technology Act, 2000, subject to the DP entering into a legally enforceable arrangement with the BO for the said purpose. The provision of transaction statements in the aforesaid manner would be deemed to be in compliance of the provisions of the Regulation 43 of SEBI (Depositories & Participants) Regulations, 1996. However if the BOs are still desirous of receiving statements in hard copy form, the DPs shall be duty bound to provide the same.

Central Database Of Market Participants

SEBI has amended the SEBI [Central Database of Market Participants] Regulations, 2003 for creation of a central database of market participants and Investors (MAPIN database), vide its notification dated 21st July, 2004 and the following are the salient features of the amendments :-

- Definition of promoter under Regulation 2(1)(n) has been amended. Pursuant to the Amendment, spouse, parents, brothers, sisters or children of promoters (where such promoter is an individual) are not required to obtain Unique Identification Number (UIN).

- Associates of specified intermediaries and directors (of these associate companies) who were required to obtain UIN under Regulation 4 (1) (b) (v) earlier are not required to obtain UIN.
- Directors and 'personnel engaged in operational activities' of asset management companies are required to obtain UIN as per Regulation 4 (1) (b) (vi-a). The term 'personnel engaged in operational activities' has been explained as 'employees comprising the top three tiers of management excluding the Board of Directors engaged in the operational activities of the specified intermediary and such other employees as may be identified by the intermediary'.
- In case of a stock broker, any approved users of terminals allotted to him by the stock exchange, including terminals installed through Computer to Computer Link (CTCL) connectivity or any other means of connectivity approved by the stock exchange, which facilitates access to trading system of the exchange, except his sub broker are required to obtain Unique Identification Number (UIN) under Regulation 4 (1) (b) (v).
- Relatives (spouse dependent children and dependent parents) of natural persons indicated in Regulation 4 (1) (b) (i-vii) i.e. relatives of Principal officer, personnel engaged in operational activities, promoters, directors of bodies corporate, partners of partnership firms, sponsors, trustees, asset managers and proprietor of proprietorship firm are not required to obtain UIN.

Proof of Identity (POI) and Proof of Address (POA) for opening a BO Account

SEBI has been continuously stressing the importance of exercising utmost care and caution while opening a BO Account. In this regard, SEBI, vide circular No.SMDRP/Policy/Cir-36/2000 dated 4th August, 2000, prescribed the documents that may be accepted as Proof of Identity (POI) and Proof of Address (POA) while opening a BO Account. For the convenience of the beneficial owners, SEBI has decided to broaden the list of documents that may be accepted as POI and/or POA for the purpose of opening a BO Account. Henceforth, a copy of any one of the following may be accepted for proof of identity / proof of address:

A. Proof of Identity

1. Passport
2. Voter ID Card
3. Driving license
4. PAN card with photograph
5. MAPIN card
6. Identity card/document with applicant's Photo, issued by
 - a) Central/State Government and its Departments,
 - b) Statutory/Regulatory Authorities,
 - c) Public Sector Undertakings,
 - d) Scheduled Commercial Banks,
 - e) Public Financial Institutions,
 - f) Colleges affiliated to Universities,
 - g) Professional Bodies such as ICAI, ICWAI, ICSI, Bar Council etc., to their Members; and
 - h) Credit cards/Debit cards issued by Banks.

B. Proof of Address

1. Ration card
2. Passport
3. Voter ID Card
4. Driving license
5. Bank passbook
6. Verified copies of
 - a) Electricity bills (not more than two months old),
 - b) Residence Telephone bills (not more than two months old) and
 - c) Leave and License agreement / Agreement for sale.
7. Self-declaration by High Court & Supreme Court judges, giving the new address in respect of their own accounts.
8. Identity card/document with address, issued by
 - a) Central/State Government and its Departments,
 - b) Statutory/Regulatory Authorities,
 - c) Public Sector Undertakings,
 - d) Scheduled Commercial Banks,
 - e) Public Financial Institutions,
 - f) Colleges affiliated to universities; and
 - g) Professional Bodies such as ICAI, ICWAI, Bar Council etc., to their Members.

SEBI has clarified that the aforesaid documents are the minimum requirement for opening a non-corporate BO Account and that DPs are required to exercise due diligence while establishing the identity of the person to ensure the safety and integrity of the depository system.

Investor Seminar:


