CDSL is pleased to announce the launch of a SMS alert (SMART) facility w.e.f. October 01, 2007, whereby Beneficial Owners (BOs) in CDSL will receive SMS alerts pertaining to debits and IPO / Corporate Action credits in their demat accounts.

To avail this facility, BOs should register their mobile numbers with their Depository Participants (DPs). The detailed procedure for registration for the SMART facility will be communicated to DPs shortly.

COMPLIANCE TRAINING PROGRAMME FOR INTERNAL & CONCURRENT AUDITORS OF DPs

To enhance the quality of internal audit reports, CDSL has decided that, at least one person conducting the internal

and/or concurrent audit (risk prone areas) of the DP should be BCCD certified or must participate in a training program conducted by CDSL. This requirement would be mandatory with effect from the internal audit for the half-year ended 30th September 2007 and concurrent audit of October 2007.

To assist internal as well as concurrent auditors fulfill this requirement, CDSL will be conducting a training program on compliance for auditors. The next such program will be conducted on September 13-14, 2007, from 9.30 am to 5.30 pm.

AGGREGATE VALUE OF PORTFOLIO OF SECURITIES & WAREHOUSE RECEIPTS OF THE BENEFICIAL OWNERS

In terms of Regulation 19 (a) (viii) of SEBI (Depositories and Participants) Regulations, 1996 the aggregate value of the portfolio of securities of the beneficial owners held in dematerialized form in a depository through a Stock Broker DP, shall not exceed 100 times of the net worth of the stock broker. Further, where the stockbroker has a minimum net worth of Rupees Ten Crore, the limits on the aggregate value of the portfolio of securities of the beneficial owners, held in dematerialized form in a depository through him, shall not be applicable.


In accordance with SEBI's direction, the value of warehouse receipts held by the beneficial owners in dematerialized form through a Stock Broker will now be taken into consideration while calculating the total permissible custodial limit for Stock Broker DPs.


Depository Participants

As on August 31, 2007, CDSL has 386 DPs offering live DP services from 650 locations in 123 cities/towns across the country.




Securities Admitted

KNOWLEDGE CENTRE - NOMINATION FACILITY

In the depository system, Beneficial Owners/ Demat account holders (BO) are allowed to nominate any person to whom the securities shall be transmitted in the event of the BO's death. The nomination facility thus reduces the problems normally faced by the legal heirs in getting the securities transmitted in their favour.

In the interest of BOs, CDSL urges all BOs, to avail of the nomination facility by submitting the nomination form, duly completed, to their DPs.

1. What are the benefits of nomination?

- In the event of death of the BO, securities can be transmitted easily to the nominee. The cumbersome process of transmission is, thus, simplified.
- The requirement of production of succession certificate/letter of administration/probate of will is eliminated.
- A BO can nominate any person, including a minor (subject to operation by guardian).

2. Who can nominate?

Nomination can be made by individuals only applying for / holding securities on their own behalf, singly or jointly upto 2 persons. If the securities are held jointly, all joint holders are required to sign the nomination form.

3. Who cannot nominate?

Non-individuals including society, trust, body corporate, partnership firm, Karta of Hindu Undivided Family, holder of power of attorney cannot nominate.

4. Can a minor be nominated?

A BO can nominate a minor represented by a guardian.

5. Who cannot be appointed as nominee?

Trust, society, body corporate, partnership firm, karta of Hindu Undivided Family or a power of attorney cannot be appointed as a nominee.

6. Can a NRI be appointed as nominee?

Both resident Indians as well as NRIs can nominate an NRI. Similarly, an NRI can nominate a resident Indian or another NRI.

7. How many nominees can be appointed?

Every BO may nominate a person to whom his securities shall vest in the event of his death. In case the securities are held in a joint account, the joint holders may together nominate a person to whom all rights in the securities shall vest in the event of the death of all the joint holders. Thus, only one person can be appointed as a nominee

8. What measures DPs should take to encourage their BOs to appoint a nominee?

- DPs are advised to generally insist that the investor make a nomination at the time of opening the demat account.
- DPs should also consider the following avenues to popularise the nomination facility: -
 - a) Send a separate leaflet/handout along with a nomination form to their BOs, along with BO account statements /bills or other literature sent to BO bill or other literature sent to BOs.
 - b) Provide a footnote in the BO account statements /bills or other literature sent to BO bill or other literature sent to Bos.
 - Display messages on their website.
 - d) Cover the issue of nomination at the Investor Seminars.
