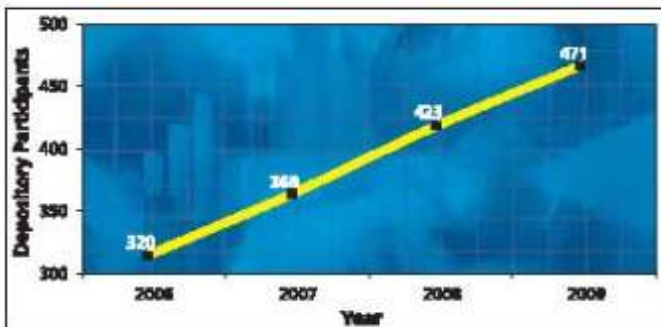
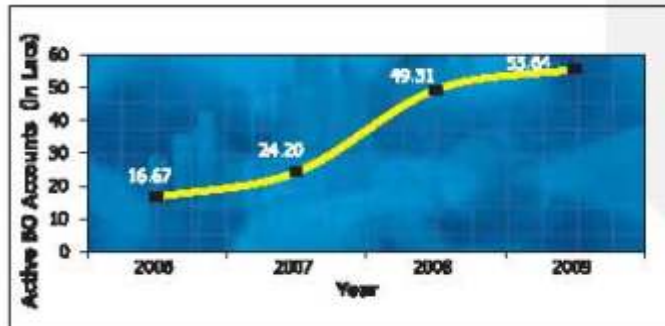

Beneficial Owners

During the last 12 months, the number of active BO accounts with CDSL has increased from 49.31 lakh on April 30, 2008 to 55.64 lakh on April 30, 2009, which indicates growth of 12.84%.

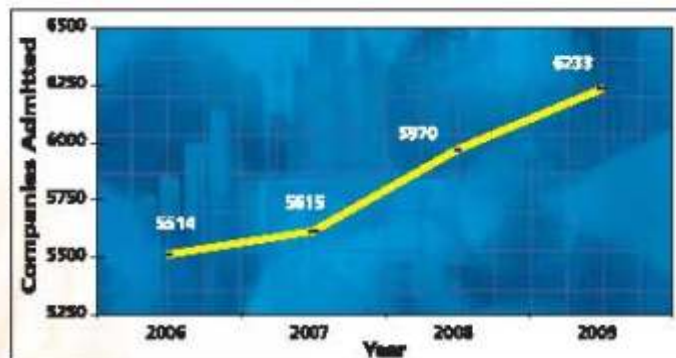


Depository Participants

As on April 30, 2009, CDSL has 471 DPs offering DP services from over 6000 locations across the country. These DPs comprise of CMs, Banks, NBFCs, Custodians, Clearing Houses/ Corporations and Regional Stock Exchanges.

Companies Admitted

The securities of almost all listed companies have been admitted with CDSL for demat. Further, a large number of Private Limited and unlisted companies are also admitted with CDSL. As on April 30, 2009, the securities of 6233 companies have been admitted for demat with CDSL.



Securities Dematerialised

During the last 12 months, the volume of securities under custody has increased by 33.47% and the value of securities has decreased by 24.23% respectively.

WHAT'S NEW ?

SETTLEMENT POCKET FACILITY – MANDATORY FOR DPs

In order to enable Clearing Members (CMs) and Depository Participants (DPs) to handle their settlements more efficiently, CDSL had introduced Settlement Pocket (SP) facility w.e.f. December 5, 2008. This system facilitates holding of balances in CM settlement accounts "settlement-ID" wise, thus providing improved control over settlement-related activities such as pay-in / pay-out and reconciliation of balances present in CM settlement accounts.

Initially, registration for SP facility was kept optional for DP and CM, as it necessitates changes in their Back-office software. W.e.f. April 4, 2009, CDSL has mandated registration of all DPs for SP facility.

INAUGURATION OF DEPOSITORY SERVICES OF JALGAON JANATA SAHAKARI BANK LTD.

Jalgaon Janata Sahakari Bank Ltd., a leading

co-operative bank, inaugurated its depository services on May 2, 2009. Shri Vijay V. Raut, Managing Director and CEO, CDSL was the Chief Guest of this event. With this service offering, investors can now avail banking and depository services under one roof at Jalgaon Janata Sahakari Bank Ltd. On this special occasion an Investor Awareness Program (IAP) was also organized, which was addressed by Shri C. S. Thakur, Head-Investor Education, CDSL. The IAP was attended by over 200 investors.

TRAINING PROGRAMMES CONDUCTED BY CDSL

With a view to improve service levels of DPs, CDSL has been conducting training programmes at regular intervals. These programmes enable DPs and its staff update themselves with latest system developments, enhanced procedures and latest regulatory / compliance requirements for smooth functioning of operations. 4 months, CDSL has conducted 16 training programmes across India on Compliance requirements and 10 training programmes on new developments such as Settlement Pocket facility, etc.

DEMAT OF SECURITIES OF DEFAULTING ISSUERS / COMPANIES UNDER LIQUIDATION

In the interest of investors and DPs, CDSL has been providing a list of top 200 companies having a large number of demat requests pending for more than 30 days, through its system and its website on a fortnightly basis.

BOs and DPs are advised to note that the Ministry of Corporate Affairs also provides a region-wise list of companies under liquidation, on its website <http://www.companyliquidator.gov.in>. DPs should regularly keep themselves updated of such companies so as to appraise BOs of the demat history of such companies prior to accepting the physical certificates for demat. BOs should also check the list of such companies available on website before submitting any physical share certificates for demat to their DP.
