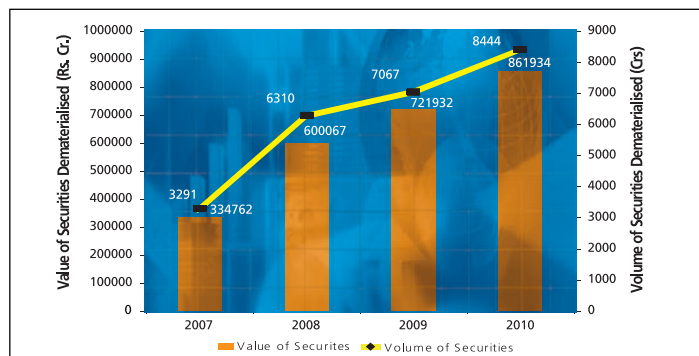
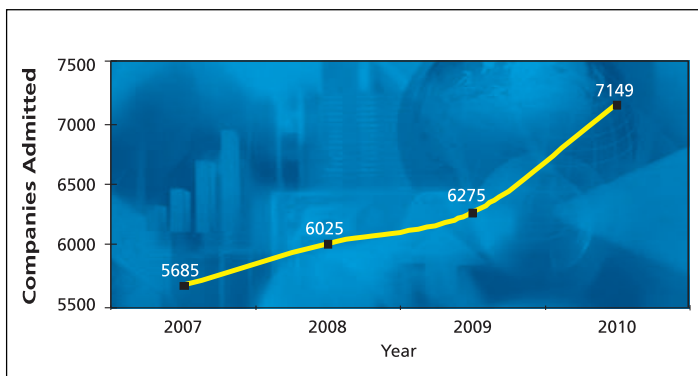


Depository Participants

Companies Admitted

The securities of almost all listed companies have been admitted with CDSL for demat. Further, a large number of Private Limited and unlisted companies are also admitted with CDSL. As on June 30, 2010, the securities of 7149 companies have been admitted for demat with CDSL.

MAINTENANCE OF ELECTRONIC WAREHOUSE RECEIPTS PERTAINING TO ACE DERIVATIVES AND COMMODITY EXCHANGE LTD.

CDSL is pleased to announce that ACE Derivatives and Commodity Exchange Ltd. (ACE), promoted by the Kotak Group, has commenced empanelment of CDSL Depository Participants (DPs) for opening accounts for holding warehouse receipts in electronic form. Beneficial Owners (BOs) intending to hold warehouse receipts in electronic form would require to open a separate demat account with one of the ACE empanelled DPs. In the CDSL system, such accounts would be opened under separate product and sub-status code. Clearing Members (CMs) may note that commodities held in their NCDEX or MCX or NSEL CM account would not be eligible for delivery / settlement in ACE. CMs dealing or trading in commodities in ACE would have to open separate CM Pool account with an empanelled CDSL DP.

A BO intending to take delivery of commodities from the warehouse would be able to do so after following the remat procedure prescribed by CDSL. Initial credits of electronic warehouse receipts in a demat account would be effected by way of Corporate Action / IPO functionality.

INCREASE IN TIME DURATION FOR UPLOADS THROUGH *Easiest*

BOs, CMs and DPs are aware that the duration of the upload window in CDSL's internet facility *Easiest* is available to users from 8 a.m. to 8 p.m. from Monday to Saturday. CDSL is now pleased to announce that the duration of the upload facility in the *Easiest* system has been increased from 4 a.m. to 11.30 p.m. from Monday to Friday or any such cutoff time as set by CDSL from time to time. On Saturdays, this facility will be available from 4.00 a.m. to 8.00 p.m.

From Monday to Friday, the upload files received between 4.00 a.m. till 8.00 p.m. or any such cut off

time as set by CDSL, will be processed on the same business day and those received between 8.00 p.m. to 11.30 p.m. will be processed on the start of day (SOD) of the next business day. On Saturdays, such files will be processed on the same business day.

CLOSURE OF ACCOUNT WITH PENDING DEMAT REQUEST

In case a BO wishes to close his account, the same cannot be closed if there are any pending demat requests. In order to facilitate hassle free closure of account, CDSL has framed the following procedure:

- On initiating closure of demat account in CDSL system, the status of account will change from 'Active' to 'To Be Closed', if the account contains any pending demat requests. The status will remain as 'To Be Closed' until the Registrar and Transfer Agent (RTA) confirms / rejects the demat request.
- In case a demat request is pending for more than 60 days, the BO should request the DP by submitting a letter in prescribed format, to cancel the said demat request(s) and close the demat account.
- The DP should forward BO's letter to CDSL along with a covering letter (in prescribed format) requesting CDSL to cancel the said demat request(s).
- Upon cancellation of pending demat requests by CDSL, the BO account will be closed automatically during the EOD process on the date when all balances in such account becomes 'zero'.

BOs and DPs are advised to take note of the same.

DISCLOSURE OF REGULATORY ORDERS AND ARBITRATION AWARDS ON CDSL WEBSITE

In order to improve transparency, SEBI, vide Circular

no. CIR/MRDDP/19/2010 dated June 10, 2010 has directed CDSL to post all regulatory orders, i.e. orders against listed companies, depository participants, trading / clearing members and arbitration awards issued by CDSL - on its website.

CANCELLATION OF UNPROCESSED PLEDGE / UNPLEDGE / CONFISCATION REQUESTS

It was observed that a large number of pledge / unpledge / confiscation requests are unexercised over a considerable period of time, after the same are set up in CDSL system. In order to streamline the process, CDSL had decided to cancel such requests which remain unexercised for more than 15 days from the date of set up, automatically.

Further, some of the pledge / unpledge / confiscation requests which are set up but unprocessed, may get cancelled / closed / transferred due to auto corporate action. DPs may note that intimation of such cancellations will be provided to the DPs along with reports generated by CDSL system, in the form of acknowledgement copies.

Pledgor DPs and Pledgee DPs are once again advised to ensure that pledge / unpledge / confiscation requests are processed within 15 days from the date of set up or any such period as specified by CDSL from time to time.

SMS ALERTS FOR FAILURE OF UPLOAD FILES DURING EOD

In June 2009, CDSL had announced that DPs would be able to upload transaction / account opening batches to the CDSL system 24x7 even when the End of Day (EOD) process was in progress, except during one hour exception window from start of EOD or any such re-scheduled time as advised by CDSL. Files

uploaded during EOD would be processed immediately after Start of Day (SOD).

CDSL is pleased to announce that SMS alert will be sent to the Compliance Officer of the DP or an alternate mobile number of the DP as registered with CDSL, in the event of failure of an upload file executed during EOD. Such alert will also be sent to the compliance officer / registered official of the DP in case of failure of files uploaded through easiest during the EOD process. This will enable the DP to initiate corrective steps immediately.

DISCONTINUATION OF CREDITS TO CM's SPECIAL PURPOSE SETTLEMENT POCKET (SPS1)

As DPs are aware that in case of Inter Depository transfers, if the 13 digit settlement ID filled in by the BO or CM in the delivery instruction slip is invalid, then the securities are credited to the Special Purpose Settlement Pocket (SPS1). Further, while processing Auto Corporate Action (ACA), fractional quantities from various settlement pockets within a CM account are clubbed together and proportionate credit is given to SPS1.

DPs are advised to note that w.e.f. July 3, 2010, the functionality of getting the securities credited to CM's SPS1 pocket has been discontinued. DPs are, therefore, advised to inform their investors / CMs of the other depository to mention the correct settlement number in the inter depository DIS, failing which such transactions will be rejected. Further, all securities received in CM account due to corporate action will be credited to SPS2.

TERMINATION OF RTA

DPs are advised to note that the tripartite agreement entered into between CDSL and Pinnacle Share Registry Pvt. Ltd. (RTA ID - 116) stands terminated with immediate effect. Issuers who had appointed Pinnacle Share Registry Pvt. Ltd. as their RTA are advised to appoint another RTA in its place. Further, DPs are advised not to accept any demat or remat

requests from BOs where the electronic RTA is Pinnacle Share Registry Pvt. Ltd.

BOs, Issuers and DPs are advised to take note of the same.
