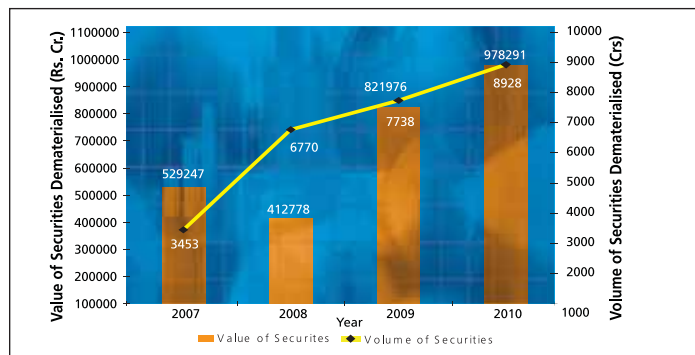
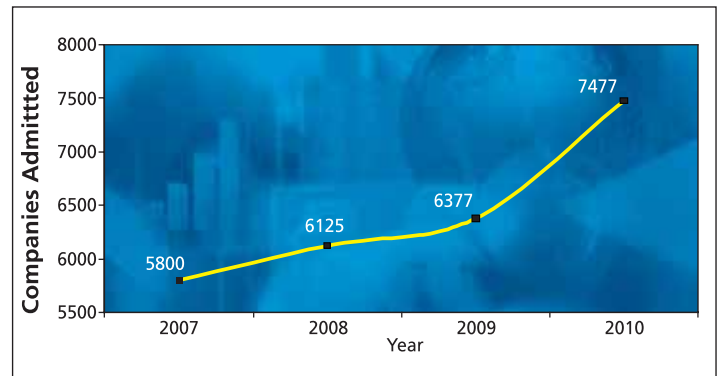


Depository Participants

As on October 31, 2010, CDSL has 525 DPs offering DP services from over 7500 locations across the country. These DPs comprise of CMs, Banks, NBFCs, Custodians, Clearing Houses/Corporations and Regional Stock Exchanges.

Companies Admitted

The securities of almost all listed companies have been admitted with CDSL for demat. Further, a large number of Private Limited and unlisted companies are also admitted with CDSL. As on October 31, 2010, the securities of 7477 companies have been admitted for demat with CDSL.

During the last 12 months, the volume of securities under custody has increased by 15.38% and the value of securities has increased by 19.02% respectively.

WHAT'S NEW ?

WAIVER OF DEBIT CHARGES FOR TRANSACTIONS IN OPEN - ENDED MUTUAL FUNDS

Currently Mutual Fund (MF) investors holding units in multiple schemes are required to manage multiple folios and statements with multiple agencies. With a view to mitigate the problems faced by MF investors, CDSL had admitted open ended units so as to enable investors to hold their entire portfolio in their demat account. Further, CDSL had also waived the debit charges on its Depository Participants(DP) for transactions in open-ended mutual funds upto September 30, 2010. This waiver of debit charges for open ended MF transactions has been further extended upto March 31, 2011.

OPENING OF NSCCL COLLATERAL ACCOUNTS IN CDSL BY SHCIL

CDSL is pleased to announce that Stock Holding Corporation of India Limited (SHCIL) has opened the following collateral accounts in CDSL for National Securities Clearing Corporation Limited (NSCCL) which can be used for offering securities as base capital / additional base capital for National Stock Exchange Limited (NSE).

NSE CMs can now directly hold their securities in their CDSL accounts and offer them as base capital / additional base capital to NSE.

TRANSFERABILITY OF MUTUAL FUND UNITS

SEBI vide its circular No. CIR/IMD/DF/10/2010 dated August 18, 2010 has issued guidelines with regard to "Transferability of Mutual Fund Units". As per the said circular, w. e. f. October 1, 2010, it has been decided to facilitate transferability of units of mutual funds held in one demat account to any other demat account. However, restrictions on transfer of units of ELSS schemes during the lock-in period shall continue to be applicable as per the ELSS guidelines.

For further details, DPs may refer to CDSL communiqué no. CDSL/OPS/DP/2087 dated August 18, 2010.

WAIVER OF OBTAINING A DIS FOR TRANSMISSION REQUESTS

With a view to make it convenient for investors to shift their accounts, CDSL had earlier waived the requirement of submitting a Delivery Instruction Slip (DIS) at the time of account closure due to "Shifting of account". CDSL has also received several representations to waive this requirement in case of the death of any one of the joint holders. In view of the same, CDSL has decided that the the surviving holder need not submit a DIS along with the Transmission Request Form.

ECS MANDATE FOR BENEFICIAL OWNER DEMAT ACCOUNTS

CDSL had informed its DPs about the Clearing House Centers which are managed by Reserve Bank of India where the refunds/dividends are distributed only through ECS. DPs are advised to regularly download the list of such centers which is available as "List of ECS Centres" at following link: <http://www.rbi.org.in/scripts/ECSUser.aspx>. If the bank account of the BO is located at any of the ECS Centers, then the DP should ensure that the ECS Mandate Flag for such BOs is "Y" in the CDSL system.

Further, in response to requests from its DPs, CDSL regularly uploads a file to the DP's which contains a list of active accounts, where the ECS Mandate Flag is "N" and MICR captured in the said account is not updated. DPs are advised to check such accounts against the list of ECS centers and update the ECS Mandate Flag.

CDSL'S CORPORATE SOCIAL RESPONSIBILITY (CSR) PROGRAM



As a part of its Corporate Social Responsibility (CSR), CDSL had decided to empower 'Physically Challenged' & 'Under Privileged' individuals by providing them training and an opportunity to work at a DP's office. Accordingly, 40 eligible individuals were identified with the help of Pratham, a reputed NGO.

These shortlisted candidates were nominated for a training program at the BSE training Institute for a period of 4 weeks followed by a 5 Day CDSL DP Training Program. The successful candidates were, thereafter, placed as 'Interns' with some of the DPs of CDSL for a period of 3 months. In order to ensure that the DPs partnering with CDSL in this initiative are not inconvenienced, a monthly stipend was paid to the candidates by CDSL. After successful completion of the internship, almost all candidates were successfully placed at various CDSL DPs. At a valedictory function held on October 6, 2010, certificates were presented to the candidates who successfully completed the training program as well as the internship.



With this initiative, CDSL has been able to proactively assist under-privileged individuals in obtaining suitable employment in the financial services domain and help them and their families to lead a more dignified life. This initiative has also facilitated CDSL DPs to employ CDSL trained and certified candidates to handle their DP operations.

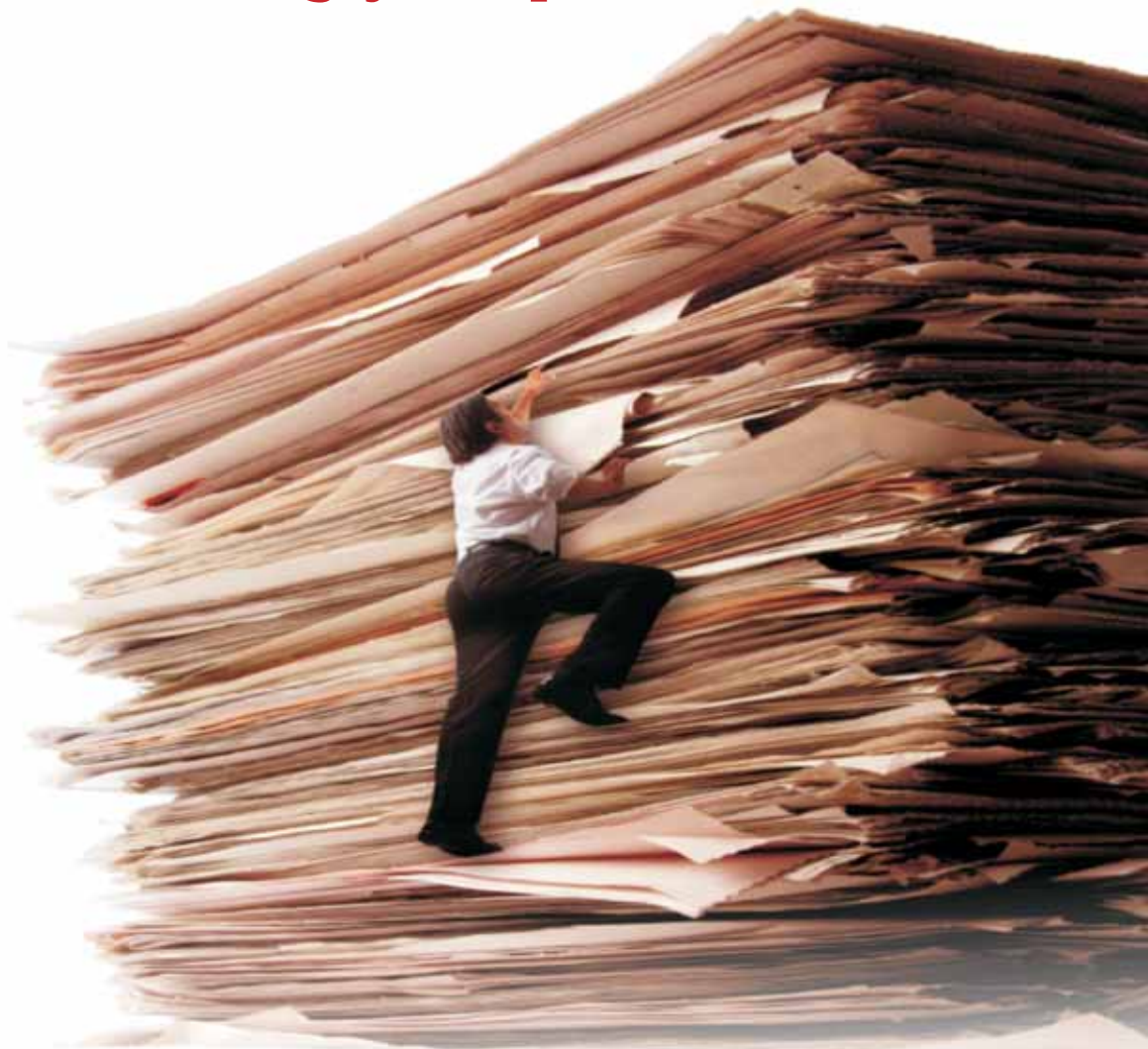
