



Depository Participants

CDSL is pleased to inform that the Board of Directors at its meeting held on 16th April, 2012, upon recommendations of the Nomination Committee, elevated Shri P. S. Reddy, whole-time Director to the position of Managing Director & CEO with effect from 16th April, 2012.

SUCCESSFUL FACILITATION OF ELECTRONIC VOTING

CDSL has successfully facilitated electronic Voting for the Postal Ballot resolutions of Piramal Healthcare Limited, Jubilant Foodworks Limited and Sadbhav Engineering Limited through its e-Voting Platform. Shareholders of these companies took this opportunity to cast their votes on www.evotingindia.com.

Many Companies have welcomed the initiative and have signed up for CDSL's e-Voting System for Corporates. The e-Voting System was inaugurated on November 17, 2009 by Hon. Minister of Corporate Affairs, Shri. Salman Khurshid. The platform aims at reducing the administrative and storage costs associated with Postal Ballots as well as AGMs / EGMs while facilitating declaration of results immediately after the close of the voting. Additionally investors can cast their votes at their convenience from home / office upto the last day. As of April 30, 2012, seven companies have used CDSL's e-Voting platform to conduct electronic voting for postal ballots collectively on eight occasions.

DEMAT OPTION FOR MUTUAL FUND UNITS THROUGH SYSTEMATIC INVESTMENT PLAN (SIP)

SEBI vide its circular **CIR/IMD/DF/9/2011** dated May 19, 2011 had provided an option to investors to hold mutual fund units in demat form. It had advised the Association of Mutual Funds in India (AMFI) that the demat option for Systematic Investment Plan (SIP) may be implemented with effect from January 01, 2012. Mutual Funds (MFs) / Registrar and Transfer Agents (RTAs) are also implementing procedure for facilitating conversion of mutual fund units into demat form in respect of existing SIPs as well as new subscriptions of SIPs.

Therefore, for conversion of mutual fund units into demat form with SIP facility, the clients can opt for 'ALL' option for conversion instead of 'quantity' option. This will enable MFs / RTAs to transfer the available units at their end to the demat account of the investors.

Depository Participants (DPs) and Beneficial Owners (BOs) are advised to take note of the same.

CLEARING AND SETTLEMENT OF OTC TRADES IN COMMERCIAL PAPER (CP) & CERTIFICATES OF DEPOSIT (CD)

SEBI vide its circular no. CIR/IMD/DF/8/2012, dated March 5, 2012, has provided its guidelines on clearing and settlement of trades in Commercial Paper and Certificates of Deposit through Clearing Corporation. For further details, please refer to CDSL communiqué no. CDSL/OPS/DP/POLCY/2948.

DISCONTINUATION OF DP49, DP83 & DP99 REPORTS

CDSL, vide its circular no. CDSL/OPS/DP/REPRT/2440, dated May 10, 2011, had advised its DPs to mandatorily use the Single Download Report [DP57 Report] with effect from June 01, 2011, as DP57 would replace various reports provided in the CDSL system. The following reports have, therefore, been discontinued with effect from April 13, 2012:

ADDITIONAL FACILITY IN PLEDGE MODULE

CDSL is pleased to announce the provision of a new facility in its Pledge module. CDSL system will now generate an acknowledgement copy for the Pledgor BO at the End of Day (EOD) for any modification in the Agreement Number and Pledge Expiry Date.



RESTATEMENTIZATION OF MUTUAL FUND UNITS

CDSL had earlier permitted its DPs to retain the original MF-RRF [Mutual Fund - Restatementization Request Form] on receipt of a Mutual Fund remat request from the Beneficial Owner (BO). Pursuant to amendments in CDSL's operating instructions, DPs are now required to send the original MF-RRF along with an acknowledgement letter generated by the CDSL system, to the RTA for processing of the request.

MODIFICATION OF KYC DATA

CVL, vide its communiqué number CVL/OPS/INTERM/ GENRL/12-015 dated April 10, 2012 has clarified that a client can modify KYC information (previously verified by KRA) on submission of duly filled Modification form along with the documentary proofs to the intermediary. The same may be updated by an intermediary through his KRA login, using the Modify KYC option under the KYC menu.

All the existing regulations and procedures pertaining to new KYC entry and dispatch would also apply to modifications in KYC data.

Formats for Modification Form for individual and non-individual category are available in the afore mentioned communiqué no. CVL/OPS/INTERM/GENRL/12-015 dated April 10, 2012. The New KYC form may be used for modification of KYC data provided the word CHANGE is mentioned /affixed at the top of the KYC form.

UPLOADING OF THE EXISTING CLIENTS' KYC DETAILS IN THE KYC REGISTRATION AGENCY (KRA) SYSTEM BY THE INTERMEDIARIES

SEBI has vide its circular no. MIRSD/ Cir-5 /2012, dated April 13, 2012 directed intermediaries to upload the KYC details of their existing clients (clients registered prior to January 1, 2012) in the KRA system, in a phased manner.

Existing clients who trade / invest / deal with the intermediary anytime during the time periods specified in the said circular, starting from April 16, 2012, the intermediaries shall forthwith upload their KYC details in the KRA system. Intermediaires shall also send original KYC documents (Account Opening Form, POI and POA documents obtained at the time of account opening) to the KRA on continuous basis and complete the process within the prescribed time limits.

Intermediaries, may send printouts of scanned documents to the KRAs instead of original documents in accordance with the schedule, certifying that they have retained the originals. However, the process of sending the original documents to the KRA should be completed by March 31, 2013. The KRAs shall update their systems and send letters to the clients for the receipt of the initial / updated KYC documents from intermediary in accordance with the time schedule. The intermediaries shall maintain electronic records of the KYCs of their clients.

For detailed time schedule for implementation, please refer to the above mentioned SEBI circular.

UTILITY FOR CONVERSION OF CLIENT MASTER DATA INTO KRA UPLOAD FORMAT

With a view to facilitate the KYC data upload, CVL-KRA has provided a conversion facility for its intermediaries through which they can generate KYC upload files from the Depository Client Master Reports. The details from the client master report can be converted into Microsoft Office Excel format and after filling in the incomplete mandatory details in the excel sheet, the same should be converted to XML. CVL-KRA had earlier provided the utility to convert excel to XML through its communiqué number CVL/OPS/INTERM/GENRL/12-010, which is available in the View Communiqués Link under the Downloads menu. Details regarding the mandatory and non-mandatory fields should be referred to in the File Structures Link provided under the Downloads Menu on www.cvlkra.com.
