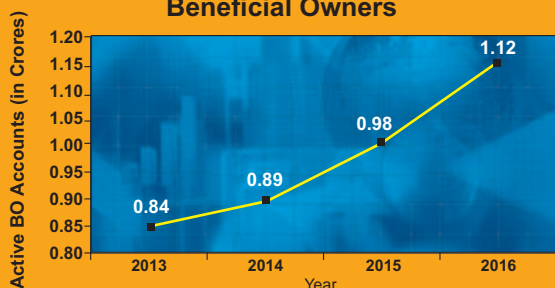

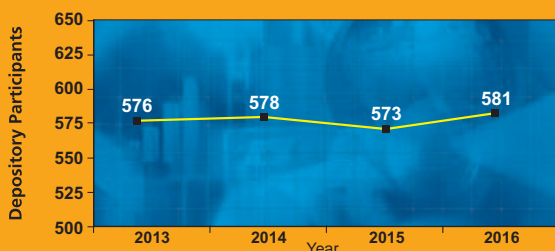

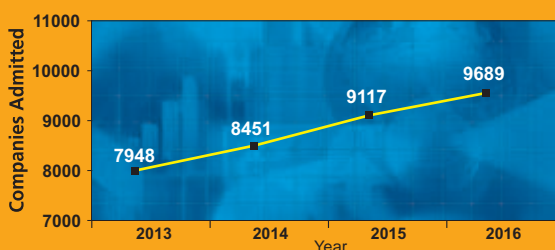

Depository Participants



As on June 30, 2016 CDSL has 581 DPs offering DP services from over 16,500 locations across the country. These DPs comprise of CMs, Banks, NBFCs & Custodians.

Unique Companies Admitted



The securities of almost all listed companies have been admitted with CDSL for demat. Further, a large number of Private Limited and unlisted companies are also admitted with CDSL. As on June 30, 2016, the securities of 9761 unique companies have been admitted for demat with CDSL.

GET ACCESS TO CDSL’s DEPOSITORY APPLICATION USING INTERNET

CDSL, vide its communique no. [CDSL/OPS/DP/SYSTEM/5754](#), had informed its Depository Participants (DPs) about two-factor authentication for users that connect to depository application using online / internet facility through REL-ID solution. CDSL is pleased to inform that it has successfully completed the implementation of two-factor authentication at log-in for all users and DPs can now access CDSL’s browser based CDAS application using Internet as well as Intranet (i.e. private WAN connectivity) with the same level of security.

DPs can access CDSL’s browser based application by procuring optimum bandwidth of internet on the basis of their business requirement and volumes. The above initiative will help DPs in reducing existing recurring cost of maintaining dedicated Intranet connectivity. DPs are advised to run CDSL application using their own Internet connectivity for 2 to 4 weeks in order to evaluate the performance level of operating the CDAS application using internet.

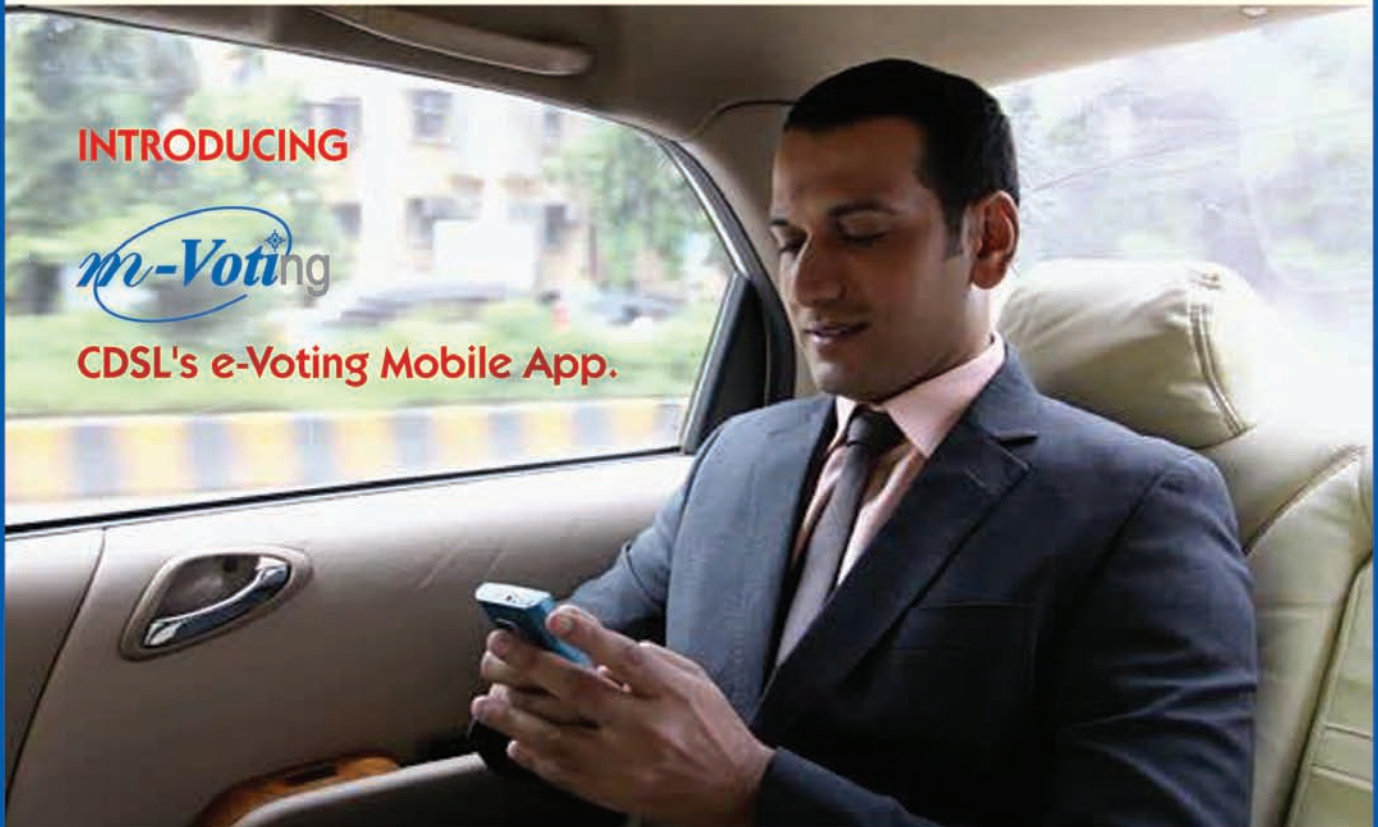

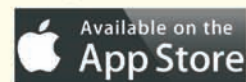
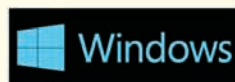
