





Unique Companies Admitted



CDSL's CSR INITIATIVE- CONSTRUCTION OF NEW DORMITORY AND NEW MULTIPURPOSE HALL FOR ADHAR



CDSL and its group company has sponsored for construction of New Male Dormitory with the capacity of 50 special adults for Adhar.

SEBI CIRCULAR – MANDATORY DEMATERIALIZATION FOR TRANSFER OF SECURITIES

SEBI, vide its circular no. <u>SEBI/LAD-NRO/GN/2018/24</u> dated June 08, 2018, had made amendments to SEBI (Listing Obligations and Disclosure Requirements). As per the aforesaid amendment, transfer of securities of listed companies shall not be processed unless the securities are held in the demat form with the depository. Transmission or transposition of securities will be exempted from the amendment. The procedure was to be made effective from December 05, 2018.

Subsequently, SEBI has received representations from shareholders for extension of the date of compliance. In view of the same, SEBI vide its press release dated December 03, 2018 informed that the deadline has been extended and the aforesaid requirement of transfer of securities only in demat form shall now come into force from April 01, 2019.

Investors may approach any CDSL Depository Participant to open a demat account or to demat their physical shares in their existing demat account before the deadline. Kindly visit www.cdslindia.com for CDSL DP list.
