



During the last 12 months, the number of active BO accounts with CDSL has increased from 2.12 Crore as on March 31, 2020 to 3.34 Crore as on March 31, 2021, which indicates growth of 57.55 %.

Depository Participants



As on March 31, 2021 CDSL has 592 DPs offering DP services from over 20,600 locations across the country. These DPs comprise of CMs, Banks, NBFCs & Custodians.

Companies Admitted



The securities of all active listed companies have been admitted with CDSL for demat. Further, a large number of Private Limited and unlisted companies are also admitted with CDSL. As March 31, 2021, the securities of 16,464 companies have been admitted for demat with CDSL.

MANDATORY UPDATION OF KYC ATTRIBUTES OF INVESTORS IN DEMAT ACCOUNT

After due consultation with SEBI and other market infrastructure intermediaries (MIIs), it has been decided to make 6 KYC attributes mandatory in the demat account for all category of investors.

The 6 KYC attributes that shall be sought mandatorily by your Depository Participants (DPs) are as follows:

- 1. Name
- 2. Address
- 3. PAN
- Valid Phone Number
- 5. Valid email id
- 6. Income Range

The checks for the above attributes are as follows:

i. Checks for PAN

- a. The requirement of mandatory submission of PAN for transactions in the securities market shall continue to apply, with permitted exemptions.
- b. Your PAN shall be verified online by your DP using the Income Tax site.
- c. In case PAN is not seeded with AADHAAR before the date specified by the Government, it will not be considered as a valid PAN.

ii. Checks for mobile number and email ID

- a. Investors are requested to update their mobile number and email address with their DPs. However, if investors wish to update mobile number and email address of their family members in the demat account, they may do so by submitting a written declaration. Family for this purpose has been defined as self, spouse, dependent parents and dependent children.
- b. If the same mobile number / email ID is captured in more than 1 demat account and family flag is also not updated, DP shall be sending a 15 days notice to such investors for submitting the Modification form /request letter. Failure to comply with which would result in classification of such accounts as noncomplaint accounts.

- c. DPs shall ensure that the mobile numbers/ email addresses of DPs /their KMPs/ other employees etc. are not captured in an investor's demat account.
- d. In case DP has the mobile number and email ID of the client in its back office, or trading account or in the bank account provided by the client and account is KYC complied in such trading account / bank account, the DP may update the details in the demat account and intimate the investor by sending the Client Master Report [CMR] along with an intimation to complete the validation process.
- e. Investors are requested to check that the existing email id and mobile numbers in their demat account are valid and do not contain junk or invalid characters.

iii. Verification of mobile number and email ID

- a. CDSL shall take necessary steps to verify that mobile number and email ID updated in the demat account of the investor is accessible by sending an SMS and email directly to the demat account holder. Investors will be required to provide an electronic confirmation from the said mobile number and email ID after which such mobile number and/or the email ID will be considered as verified.
- b. CDSL will start sending such verification links to new accounts and subsequently, such links will also be sent for all existing accounts in a staggered manner.
- Accounts where the mobile number or email id cannot be verified shall be considered as non-complaint accounts.

iv. Income Range

a. Individual and non-individual demat account holders are requested to update their income range per annum as per the format provided by their depository participants (DPs).

Implementation:

- All 6-KYC attributes shall be mandatory for new accounts opened from June 1, 2021.
- b. In respect of all existing demat accounts, all 6 KYC attributes should be updated by May 31, 2021. Investors are requested to respond to any such communication sent to them by their DPs and update the details before the deadline.
- Investors shall be informed through both physical and electronic modes and also through the DP's website,

- if any, for updating the details and complete the validation process.
- d. Non-compliant demat accounts will be liable to be made inactive i.e., no debit will be allowed in such demat account (except for settlement of already open positions).

Investors are requested ensure compliance while opening a new demat account and filling KYC details. DPs are also advised to ensure adequate due diligence while on-boarding of new demat account holders and while conducting their KYC. For further details you may refer to CDSL communique no. CDSL/OPS/DP/POLCY/2021/152, dated April 5, 2021.

EMAIL ADDRESS UPDATION FACILITY FOR CDSL DEMAT ACCOUNTS

CDSL is pleased to introduce its new email address updation service for companies whose shareholders have not provided their email address in their demat account with the Depository Participant. For the said activity, CDSL shall send an SMS with a demat account specific link to the registered mobile number as available in the demat account of shareholder to initiate the process of email address updation of the shareholders of the company. CDSL will also send emails to those shareholders of the company who have opted for not downloading their email address to the RTA. For a detailed procedure please refer CDSL communique CDSL/ADM/RTA/GENRL/2020/71 dated June 11, 2020.

CONDUCTING OF AGM THROUGH VIDEO CONFERENCING (VC) OR OTHER AUDIO-VISUAL MEANS (OAVM)

In view of the situation arising due to COVID-19 global pandemic, the general meetings of the companies shall be conducted as per the guidelines issued by the Ministry of Corporate Affairs (MCA) vide <u>Circular No. 14/2020</u> dated April 8, 2020, <u>Circular No.17/2020</u> dated April 13, 2020 and <u>Circular No. 20/2020</u> dated May 05, 2020.

The forthcoming AGM/EGM will thus be held through video conferencing (VC) or other audio-visual means (OAVM). Hence, Members can attend and participate in the ensuing AGM/EGM through VC/OAVM. We are pleased to inform you that the facility of casting votes by shareholders using remote e-voting as well as the e-voting system on the date of the EGM/AGM and VC/OAVM service will be provided by CDSL.

- 1. The Members can join the EGM/AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the EGM/AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the EGM/AGM without restriction on account of first come first served basis.
- The attendance of the Members attending the AGM/ EGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
- 3. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM/EGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM/EGM through VC/OAVM and cast their votes through e-voting.
- 4. Only those shareholders, who are present in the EGM/ AGM through VC/OAVM facility and have not casted their vote on the Resolutions through remote e-Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system available during the EGM/AGM.
- 5. Shareholders who have voted through Remote e-Voting are eligible to attend the EGM/AGM. However, they are not eligible to vote at the EGM/AGM.

INVESTOR AWARENESS PROGRAMMS (IAPs)

CDSL IFSC LIMITED

"Central Depository Services (India) Ltd, has obtained approval from International Financial Services Centres Authority (IFSCA) vide reference no 187/IFSCA/CDSL/2020-21 dated 12th March 2021 to set up separate Subsidiary at Gift CITY.

CDSL floated wholly owned subsidiary company in the name and form of 'CDSL IFSC Limited' was with an initial investment of Rs.5 crore, constituting 5 crore shares of Re.1/- each with an additional investment of Rs.15 crore thereafter. CDSL IFSC Limited has received the Certificate of Incorporation on March 30, 2021.

CDSL IFSC Ltd has been recognized as foreign depository by IFSCA.

- Equity shares of a company incorporated outside India.
- Depository receipt(s);
- o Debt securities issued by eligible issuers.

As allowed by IFSCA

CDSL IFSC Limited plan to establish linkages amongst Global CSDs for Clearing and Settlement of delivery-based transactions of all permissible securities traded at IFSC.

CDSL IFSC Limited will also enroll DPs to carry out activities permitted by IFSCA."

CDSL COMMODITY REPOSITORY LIMITED



Since only agricultural commodities are notified by WDRA as of now, delivery settlements of derivative contracts in only agricommodities are facilitated by CCRL currently.


Salient features of CCRL Repository system -


- One-time KYC process Repository Participant (RP) verifies the documents submitted by a depositor and issues a Client ID, which is instant and unique. Once such Client ID is obtained by any depositor, there is no need for any KYC for depositing goods at any registered warehouse across India. This Client ID is compatible with all registered warehouses. Moreover, depositor can store multiple commodities' eNWR in the same account.
- Secure transactions The Deposit and Withdrawal transactions are OTP based. This provides additional security and confidence to account holders because no transaction can get concluded without they sharing such OTPs to their RP/ warehouse.
- Integrated services Repository services can be integrated with Banks, Warehouses and RPs, making it seamless and easy for users.
- Real time access and record keeping The records are updated instantaneously in Repository. There is no lag time which could have created risk/ loss to users.

- Flexibility of creating users For RPs and Warehouses, multiple users can be created and operating rights for such users can be controlled by the admin user. This gives immense benefit to such operators who have huge spreadout operations and different teams to handle different tasks.
- 6. Business continuity & Disaster recovery plans Repository operates with foolproof Business continuity & Disaster recovery infrastructure and plan in place. Under no circumstances, the access and working of Repository gets disrupted. This gives required confidence to all stakeholders, users and clients to operate without worrying about their data stored with Repository.
