




During the last 12 months, the number of active BO accounts with CDSL has increased from 2.70 Crore as on October 31, 2020, to 4.96 Crore as on October 31, 2021, which indicates growth of 83.70 %.

Depository Participants



As on October 31, 2021, CDSL has 592 DPs offering DP services from over 21,000 locations across the country. These DPs comprise of CMs, Banks, NBFCs & Custodians.

Companies Admitted



The securities of all active listed companies have been admitted with CDSL for demat. Further, a large number of Private Limited and unlisted companies are also admitted with CDSL. As October 31, 2021, the securities of 17,874 companies have been admitted for demat with CDSL.

CDSL VENTURES LIMITED (CVL) GETS NOD FOR PROVIDING ESIGN SERVICES

The Controller of Certifying Authorities (CCA) has accorded its approval to CDSL Ventures Limited ("CVL") to provide eSign services. Further, CCA has empaneled CVL as an eSign Service Provider (ESP) to provide eSign services to Application Service Providers (ASP) based on online Aadhaar eKYC.

eSign or Electronic Signature Service can be integrated with various applications to facilitate digital signing of a document, by authenticating Aadhaar based e-KYC of eSign user. eSign provides benefits which includes convenience and security to citizens, while organizations save on time, achieve streamlined processes, and reduce the costs associated with handling and storage of paper.

Currently, CVL is also registered with UIDAI as AUA/KUA to offer Aadhaar based EKYC services. CVL's Aadhaar based eKYC services coupled with the eSign service will facilitate intermediaries to offer seamless online account opening using online Aadhaar based eKYC and eSign. CVL has also launched an Online Account Opening (OLAO) software for facilitating intermediaries to perform online KYC and open demat and broking accounts of their clients. CVL's OLAO provides a thrust to seamless online account opening using online Aadhaar based eKYC and eSign.

PROVISION OF REDIRECTION FACILITY FOR EVOTING OF LISTED COMPANIES

Sebi, vide its circular no. <u>SEBI/HO/CFD/CMD/CIR/P/2020/242</u>, dated December 9, 2020, had decided to enable evoting of individual demat account holders through a single login credential, through the demat accounts or websites of depositories or depositary participants (DPs).

With a view to implement the aforesaid circular, CDSL is pleased to announce the provision of a facility that will enable its DPs to redirect its Beneficial Owners (BOs) from their own websites to the CDSL BO Centre and provide them a direct access to do e-Voting. Individual Shareholders having a demat account can logon to the online trading portals of their DPs/Brokers and get redirected to CDSL's BO centre. Upon redirection, an initial authentication will be done through the evoting menu of the BO Centre using an OTP. Individual demat account holders will then be able to cast their vote on the evoting portal of CDSL or any evoting service provider (ESP) without any further authentication.

CDSL has provided an API facility to its depository participants in this regard. CDSL IFSC LIMITED

Central Depository Services (India) Ltd, has obtained approval from International Financial Services Centres Authority (IFSCA) vide reference no 187/IFSCA/CDSL/2020-21 dated 12th March 2021 to set up a Subsidiary at IFSC, GIFT City.

CDSL floated wholly owned subsidiary company in the name and form of 'CDSL IFSC Limited' was with paid up capital of Rs.20 Crores.

CDSL IFSC Ltd has been recognized as the first and only foreign depository by International Financial Services Centres Authority (IFSCA). Additionally, IFSCA vide it letter dated 17 August, 2021 authorized CDSL as the only Bullion Depository.

In light of CDSL having the approval from IFSCA to hold both securities and bullion in the depository, Investor will able to hold following Securities through CDSL IFSC Limited

- Equity shares of a company incorporated outside India;
- Depository receipt(s);
- Debt securities issued by eligible issuers;
- Bullion (Gold and silver)
- As allowed by IFSCA

CDSL IFSC Limited is in the process of establishing linkages amongst Global CSDs for Clearing and Settlement of delivery-based transactions of all permissible securities traded at IFSC.

CDSL IFSC Limited has also enrolled Depository Participants (DPs) to carry out activities permitted by IFSCA.

CONDUCTING OF AGM THROUGH VIDEO CONFERENCING (VC) OR OTHER AUDIO-VISUAL MEANS (OAVM)

In view of the situation arising due to COVID-19 global pandemic, the general meetings of the companies shall be conducted as per the guidelines issued by the Ministry of Corporate Affairs



(MCA) vide <u>Circular No. 14/2020</u> dated April 8, 2020, <u>Circular No. 17/2020</u> dated April 13, 2020 and <u>Circular No. 20/2020</u> dated May 05, 2020.

The forthcoming AGM/EGM will thus be held through video conferencing (VC) or other audio-visual means (OAVM). Hence, Members can attend and participate in the ensuing AGM/EGM through VC/OAVM. We are pleased to inform you that the facility of casting votes by shareholders using remote e-voting as well as the e-voting system on the date of the EGM/ AGM and VC/ OAVM service will be provided by CDSL.

- 1. The Members can join the EGM/AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the EGM/AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the EGM/AGM without restriction on account of first come first served basis.
- The attendance of the Members attending the AGM/ EGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
- 3. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM/EGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM/EGM through VC/ OAVM and cast their votes through e-voting.
- 4. Only those shareholders, who are present in the EGM/AGM through VC/OAVM facility and have not casted their vote on the Resolutions through remote e-Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system available during the EGM/AGM.
- 5. Shareholders who have voted through Remote e-Voting are eligible to attend the EGM/AGM. However, they are not eligible to vote at the EGM/AGM.
