CHANGES IN BO SETUP/MODIFY: - ENTRY OF RECIPIENT DEMAT ACCOUNTS FOR CM POA HOLDER & INTRODUCTION OF ADDITIONAL FIELDS

A. Capturing of Recipient demat accounts for stock broker POA holders.

DPs are advised to refer to SEBI Circular no. **CIR/MRD/DMS/13/2010** dated April 23, 2010 and SEBI Circular no. **CIR/MRD/DMS/28/2010** dated August 31, 2010 regarding the clarifications provided by SEBI for execution of Power of Attorney by the client in favour of the Stock Broker/ Stock Broker and Depository Participant [DP].

As per the aforesaid circulars, for the POA executed in favour of Stock Broker and DP by the client, the POA document should provide a list of Clients & Brokers demat account where funds and securities can be moved. Such list may be updated / amended by proper communication without executing a new POA every time and copies of such communications may be preserved as annexure to the POA.

SEBI has now directed that the DP should ensure that in case of transactions executed by such Stock Broker POA holder, the recipient accounts should not be other than those specified in the POA and there should be system mechanism to ensure the same.

Accordingly, following functionalities are being incorporated in CDSL system.

1. Creation of Master POA ID in BO module - POA set up

- a. A new flag "Master POA type" will be introduced in CDAS to distinguish between a POA Master ID created for POA in favour of a Stock Broker (in accordance with SEBI circulars mentioned above) and other POAs. The flag "Master POA type" will have values as "C" and "R". "C" – for POAs given in favour of Stock Broker and "R" for other POAs.
- b. If the value "C" is chosen for the flag "Master POA type" then the DP will be required to enter Exchange ID, CMID and demat account numbers as mentioned in the POA document. DPs can obtain the details of CM i.e CMID, Exchange ID, from CD11 report [CM Master List]. The DPs will also be able to enter demat account numbers pertaining to NSDL, if NSDL demat account numbers are mentioned in the POA document.. Mapping of at least one CM demat account is mandatory.

- c. In case of creation of Master POA ID through uploads, a new purpose code 21 will be introduced in BO Setup Upload / BO Modify Upload. (Refer Annexures A & B). In master POA Setup / Modify upload purpose code 21 will be repeated for each CMID-Exchange ID -CM Account. DPs can map the Principal, Pool and Early Payin accounts of the CM in a single line by using mapping-unmapping flag as '3'.
- d. The DP will be able to add aforesaid account(s) as well as delete the mapped accounts through online POA Master detail modify Sub Menu / BO Modify Upload (New purpose Code 21 will be repeated for CMID-Exchange ID - CM Account with mapping unmapping flag as 1 - Mapping and 2 - Unmapping)

2. Update of existing Master POA IDs

a. For all the existing POA IDs in 'Active' status, the DP will be required to update the flag "Master POA type" with values as 'C' where the POA is in favour of Stock Broker Or 'R' in all other cases. The DP will also be required to enter Exchange ID, CMID and demat account numbers as mentioned in the POA where the flag "Master POA type" is marked as "C". The same can be updated by using BO Modify Upload or BO modify option – online entry.

3. Validations for execution of transactions:

- a. In case of transactions where DIS is issued to the Master POA ID where the flag "Master POA type" is marked as "C", the system will allow execution only if the recipient account number is mapped to the said Master POA ID and the debit BOID (all holders) is linked to the master POA ID. All debit transactions through Settlement Module (BO Confirmation, Inter Depository, Early Pay-in and Offmarket / Onmarket through Transaction Module) / common Upload where DIS issued to POA is used will be validated.
- b. For the files uploaded by the CM in 'easiest' through its easiest login, there will be a check to ensure that the recipient account (s) is/are mapped to the CM's POA ID in CDAS and the said account (s) is/are also grouped under the CM login in easiest. [Refer communiqué DP-5020 dated February 20, 2015].

4. Closure of CM demat accounts :-

a. If a CM closes its existing account with a DP and opens a new account with another DP, the CM will be required to inform the same to all BOs who have executed POA in its favor and further ask them to provide the updated list of recipient demat account numbers to their DP. Alternatively, the CM can also approach the DP directly and request for change of recipient demat account numbers against his Master POA ID set

up by the said DP. The CM should provide a declaration to the DP stating that he has informed all the concerned BOs about the change in recipient demat account numbers for his Master POA ID.

b. If the account closed is a CM principal, CM pool account or Early Payin account then the account mapping for all POA link for the CM will be updated with the new account number automatically and no action is required to be taken by the DP. However in case of closure of any CM accounts, other than the CM principal, CM pool account and Early Pay-in account i.e. Client Margin account the DP has to map these accounts separately. In case the Client Margin account(s) of the CM are not mapped then the transactions will fail where such accounts are recipient demat accounts.

Existing POA Master IDs

DPs are advised to note that CDSL will be providing the dump of all existing POA master IDs and its product details in respective DP Billing folder with file name as BLNG<DPID>_POA_Master_Data_18Nov2015.zip by tomorrow i.e. by November 19, 2015 EOD. DPs are advised to update existing POA master IDs with value as 'C' or 'R' under the field "Master POA type" and map all the CM accounts mentioned in the POA document submitted by the BO on the basis of which the CM POA master ID was created. DPs are required to ensure that such update is done before release of the functionality of validations for execution of transactions by CM Master POA IDs.

DPs are advised to note that the functionality regarding mapping of accounts is scheduled for release on December 18, 2015. After this release, all new master POA IDs created will have to be created with the flag 'C' or 'R' and for 'C' type of master POA IDs, the CM accounts will have to be mapped with the POA ID. CDSL will provide updated dump of all existing POA master IDs and its product details as on December 18, 2015 in respective DP Billing folder on December 19, 2015.

The functionality of transaction validation against mapped accounts is expected to be released on Friday, January 01, 2016. The DPs should ensure that update of existing Master POA IDs should be completed before such release.

B. Other changes in the BO set up / BO modify - online entry and upload

Following new fields will be captured during BO Setup / BO modify .

- a. Date of Receipt: To capture date of account opening / account modification request from BO.
- b. Flag for family account: DPs are advised to refer to communiqué no. DP-5139 dated April 15, 2015 wherein it was provided that under exceptional circumstances, the DPs may, at the specific written request of a client upload the same mobile number / email address for more than one client provided such clients belong to one family. 'Family' for this purpose would mean self, spouse, dependent children and dependent parents. The DPs should identify such accounts by updating Family Account Flag with value Y/N. The default value for this flag is 'N'
- c. Custodian / PMS email id:- This field will be used to capture the e-mail id of custodian/PMS provider for custodial/PMS accounts to enable custodians/PMS providers to receive notifications for corporate action etc from the RTA. This field will be provided to RTAs in the benpos.

C : Other changes in the BO Closure and BO modify -signature delete/replace – online entry and upload.

Following new fields will be captured during BO Closure / BO Signature delete/replacement...

 a. Date of Receipt: To capture the date of request received for BO initiated closure and for deletion/replacement of signature.
