FACILITY TO REMEDY ERRONEOUS TRANSFERS IN DEMAT ACCOUNTS

DPs are advised to refer communique CDSL/OPS/DP/POLCY/2023/745 dated December 22, 2023, regarding facility being made available to BO/DP to add buyer account (s) as beneficiary

for all 'Off-Market' transactions to remedy erroneous transfers in demat accounts.

As per the aforementioned circular, under point no. 8 (b), DPs are further advised to refer to the **upload file format** enclosed herewith as **Annexure-A**, provisioned to add buyer account as 'beneficiary' under the seller account before executing 'off-market' 'Intra-Depository' & 'Inter-Depository' transactions. Success/Failure response report will be made available to the DPs in

webcdas front end once the file is uploaded.

DPs are also required to note that a separate 'online' report – DPU9 will be made available for DPs for download which will provide details of the buyer account added as 'beneficiary' under the seller account, the format of which is enclosed herewith as Annexure - B. DPs can download the same under 'Report' module through download option in webcdas using Module ID - 38

(Settlement), **Report ID – DPU9**.

DPs are required to note that the following facilities are scheduled for live release on **December 29, 2023**, to make it effective from **December 30, 2023**.

a) Adding beneficiaries through upload.

b) Provision of online DPU9 report for the list of the buyer account(s) added as 'beneficiary'

under the seller account.

c) Mechanism for validating buyer account as 'Beneficiary' under the seller account before

executing intra-depository / inter-depository off-market transactions.

DPs are advised to take note of the above-mentioned points and initiate suitable changes in their

back office, if any.
