The Governing Board of CDSL at its meeting held on July 02, 2024, had considered and recommended the re-appointment of Sushri Kamala Kantharaj (DIN: 07917801) as a Non-Independent Director (NID) who is liable to retire by rotation, to the Shareholders of the Company for their approval at the 26th Annual General Meeting (AGM), subject to approval of Securities and Exchange Board of India (SEBI). Thereafter, the Shareholders of CDSL at the 26th AGM held on August 17, 2024, approved the re-appointment of Sushri Kamala Kantharaj with the requisite majority.

Accordingly, CDSL sought approval from SEBI for the re-appointment of Sushri Kamala Kantharaj as a Non-Independent Director on the Governing Board of CDSL who shall be liable to retire by rotation. SEBI vide its letter dated September 12, 2024, has accorded its approval with effect from September 12, 2024.
