The accompanying Statement includes the audited financial results and other financial information in respect of 2 subsidiaries whose interim financial statements/financial information/financial results reflect total revenues of Rs. 2,929.81 lakhs, total net profit of Rs. 967.86 lakhs and total comprehensive income of Rs.956.72 lakhs, for the quarter ended June 30, 2022 ,as considered in the Statement which have been audited by their respective independent auditors.

The independent auditor's report on the interim financial statements/financial results/financial information of these entities has been furnished to us by the Management and our opinion on the Statement in so far as it relates to the amounts and disclosures included in respect of these subsidiaries is based solely on the reports of such auditors and the procedures performed by us as stated in paragraph above.

The accompanying Statement includes unaudited interim financial statements/ financial information/financial results in respect of:

- one subsidiary, which have not been audited by their auditors, whose interim financial statements/financial results/financial information reflects total revenue of Rs. 0.01 lakhs, total net loss of Rs. 38.86 lakhs, and total comprehensive loss of Rs. 24.11 lakhs upto 2nd May 2022, as considered in the Statement.
- one associate, whose interim financial results/statements include Group's share of net loss of Rs. 89.83 lakhs and Group's share of total comprehensive loss of Rs. 14.77 lakhs for the quarter ended June 30, 2022, as considered in the Statement.

These unaudited interim financial statements/ financial information/ financial results of the subsidiary and associate have not been audited by their auditors and have been approved and furnished to us by the Management and our opinion on the Statement, in so far as it relates to the amounts and disclosures included in respect of the subsidiary and associate, is based solely on such unaudited interim financial statements/ financial information/financial results. In our opinion and according to the information and explanations given to us by the Management, these interim financial statements/ financial information/financial results are not material to the Group.

Our opinion on the Statement is not modified in respect of the above matters with respect to our reliance on the work done and the reports of the other auditors and the financial results/financial information certified by the Management.

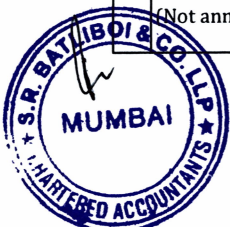

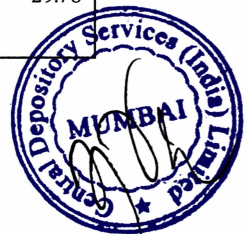




- 3 The management has, at the time of approving the financial results, assessed the potential impact of the COVID-19 on the Group. Based on the current assessment, the management is of the view that impact of COVID 19 on the operations of the Group and the carrying value of its assets and liabilities is minimal.
- 4 The Code on Social Security, 2020 ('Code') relating to employee benefits during employment and post-employment benefits received Presidential assent in September 2020. The Code has been published in the Gazette of India. However, the date on which the Code will come into effect has not been notified and the final rules/interpretation have not yet been issued. The Group will assess the impact of the Code when it comes into effect and will record any related impact in the period the Code becomes effective.
- 5 During the quarter, the Holding Company has divested 92.5% stake in its subsidiary i.e India International Depository IFSC Limited (formerly, CDSL IFSC Limited) on May 2, 2022 to its associate India International Bullion Holding IFSC Limited, thus resulting in a loss of control. The profit on sale of such investment of ₹ 111.88 Lakh (net of tax and including reclassification of foreign currency translation reserve) and after eliminating its share in the associate has been disclosed in other income.
- 6 During the quarter, the Board of Directors of Holding company and one of the Subsidiary approved an additional performance payout to its employees of ₹ 1,086 lakh, which has been recorded as charge in the current quarter.
- 7 During the previous financial year 2021-22, the group had written back an amount of ₹ 439.93 Lakh in respect of earlier years. Further, an amount of ₹ 41.11 Lakh, received as interest on refund for the said years have been included in other income for the quarter.
- 8 The figures for the quarter ended March 31, 2022 are arrived at as difference between audited figures for the year ended March 31, 2022 and the audited figures upto nine months ended December 31, 2021.
- 9 Figures for the previous period / year have been regrouped / reclassified and rearranged wherever necessary to correspond with the current period / year classification / disclosure.



Notes:

- 1 The above financial results have been reviewed by the Audit Committee and approved by the Board of Directors on July 30, 2022. The financial results have been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard (IND AS) prescribed under Section 133 of the Companies Act, 2013 read with the relevant rules issued thereunder and other accounting principles generally accepted in India.
- 2 The Company operates only in one Business Segment i.e. "Depository Services", hence does not have any reportable Segments as per Indian Accounting Standard 108 "Operating Segments".
- 3 Other Income includes Dividend Income received from a subsidiary during the quarter amounting to ₹ 4,150 Lakh.
- 4 The management has, at the time of approving the financial results, assessed the potential impact of the COVID-19 on the Company. Based on the current assessment, the management is of the view that impact of COVID 19 on the operations of the Company and the carrying value of its assets and liabilities is minimal.
- 5 The Code on Social Security, 2020 ('Code') relating to employee benefits during employment and post-employment benefits received Presidential assent in September 2020. The Code has been published in the Gazette of India. However, the date on which the Code will come into effect has not been notified and the final rules/interpretation have not yet been issued. The Company will assess the impact of the Code when it comes into effect and will record any related impact in the period the Code becomes effective.
- 6 During the quarter, the Board of Directors approved an additional performance payout to its employees of ₹ 944 lakh, which has been recorded as charge in the current quarter.
- 7 During the previous quarter ended March 31, 2022, the Company had written back an amount of ₹ 394.04 Lakh in respect of earlier years. Further, an amount of ₹ 34.75 Lakh, received as interest on refund for the said years have been included in other income for the quarter ended March 31, 2022.
- 8 During the quarter June 30, 2022, the Company has divested 92.5% stake in its subsidiary i.e India International Depository IFSC Limited (formerly, CDSL IFSC Limited) on May 2, 2022 to its associate India International Bullion Holding IFSC Limited, thus resulting in a loss of control. The sale was concluded at the current carrying value of the investment and accordingly there was no impact on the profit or earnings per share for the quarter.
- 9 The figures for the quarter ended March 31, 2022 are arrived at as difference between audited figures for the year ended March 31, 2022 and the audited figures upto nine months ended December 31, 2021.
- 10 Figures for the previous period / year have been regrouped / reclassified and rearranged wherever necessary to correspond with the current period / year classification / disclosure.
