CONSOLIDATED ACCOUNT STATEMENT (CAS) – LIST OF CAS ELIGIBLE BOIDs – MARCH 2021

DPs are advised to refer to communiqué no. **CDSL/OPS/DP/POLCY/5033** dated February 26, 2015, whereby it was informed that the list of BOIDs eligible for receiving CAS from depositories (demat account holders holding Mutual Fund (MF) units in physical – i.e. Statement of Account form) shall be provided to DPs in their Billing Folder after the monthly PAN matching process between Asset Management Companies (AMCs) / MF-RTAs and depositories is completed.

Accordingly, the PAN matching process for the month of March 2021 between AMC/MF-RTAs and CDSL has been completed. DPs are advised to note the following:

1. The list of BOIDs eligible for CAS [after excluding BOIDs wherein the 'CAS Mode' has been updated as **NO: CAS not required** (Refer serial no. 2)] for the month of March 2021 has been uploaded in Billing Folder of the DPs. The name of the uploaded file is: **"BLNG<DPID>CASBO_MAR21.zip**.
2. **CAS not required cases:** Where the 'CAS Mode' status as on March 31, 2021 has been updated as 'NO' in any BOID, then all the BOIDs across DPs wherein the first holder is the same will be excluded from the list of CAS eligible BOIDs and CAS will not be sent to all such demat accounts for March 2021.
3. **Monthly transaction statement for March 2021:** For the CAS eligible BOIDs provided in the file, CAS shall be sent by CDSL if during the month of March 2021, there is transaction either in any of the demat account or mutual fund folio held by the BO in the same pattern of holding.
4. **Half yearly holding statement as on March 31, 2021:** For the CAS eligible BOIDs provided in the file, if CAS has not been sent for any of the six months from October 2019 to March 2021, on account of nil transactions in any of the demat account or mutual fund folio held by the BO in same pattern of holding then half yearly CAS with holding details as on March 31, 2021 shall be sent by CDSL.
5. The dispatch of CAS by CDSL would constitute compliance by the DPs with requirement under Regulation 43 of SEBI (Depositories and Participants) Regulations and separate

transaction statement for the month of March 2021/half yearly holding statement is not required to be sent by the DP to such CAS eligible BO IDs.

6. DPs are also requested to note that in the CAS eligible BOs for all the transaction months would be placed by the 5th of the month following the transaction month. (E.g. List of CAS eligible BOs for transaction month March 2021 would be provided by 5th April 2021). Hence no communique would be sent for the same from now onwards.
