### EARLY REDEMPTION OF SOVEREIGN GOLD BONDS 2016 TRANCHE - II (ISSUE DATE MARCH 29, 2016)

DPs are advised to note that in terms of the Sovereign Gold Bond Scheme Procedural Guidelines issued by RBI vide circular RBI/2019-20/213, IDMD.CDD.2730/14.04.050/2019-20 dated April 13, 2020 premature redemption of bonds is permitted after five years from the date of issue of such bonds on the date on which the next interest is payable.

In accordance with the same, we have been informed by RBI that the window for submission of request for premature redemption of **Sovereign Gold Bond 2016 Tranche II (ISIN IN0020150119)** to RBI shall be open from September 15, 2021 to September 21, 2021 on all working days between 8 a.m. to 11 p.m. and on September 22, 2021 till 3 p.m.

Process to be followed for submission of the early redemption request by the client to the Participant is given below

1. The holders of bonds under the said ISIN (ISIN IN0020150119), who wish to participate in the early redemption option will be required to submit the Repurchase/Redemption Request Form (RRF) to the DP. The requests from the holders are to be **accepted by the DPs only during the period September 15, 2021 till September 22, 2021(only till 3.00 p.m).** **Please note any request entered on September 22, 2021 after 3.00 p.m. shall not be considered for early redemption.** **The requests received till the cut-off date/time shall be uploaded by CDSL on the RBI portal on September 22, 2021.**
2. The DP shall execute and forward the early redemption request electronically under **Rematerialisation module-Restat Option- Redemption** in the CDAS system.
3. Under the redemption option, the field for quantity is to be selected and the relevant quantity needs to be entered. **Please do not use the amount option.**
4. The DP shall provide the details of aforesaid request in the format enclosed at Annexure A in .xls format by e-mail (subject line of mail should be "**Early Redemption Request for SGB ISIN <ISIN Number>**") to [gsec@cdslindia.com](mailto:gsec@cdslindia.com)
5. DPs are advised to ensure the correctness of the bank details of the client in the demat account so as to avoid return of the redemption amount.
