NORMAL LIVE TRADING SESSION ON JANUARY 20, 2024, AND AVAILABILITY OF CDSL SYSTEM

DPs are advised to refer communique **CDSL/OPS/DP/SETTL/2024/4** dated **January 01, 2024**, and communique **CDSL/OPS/DP/SETTL/2024/44** dated **January 17, 2024**, informing about special live trading session on **January 20, 2024 (Saturday)** with intra-day switch over to DR site.

DPs are required to note that in view of Government of Maharashtra having declared January 22, 2024, as a public holiday under Section 25 of the Negotiable Instruments Act, 1881 there shall be a **continuous Normal Live Trading session on Saturday, January 20, 2024.**

Accordingly, DPs are advised to take note of the following revisions for business date **January 20, 2024.**

- **There shall be no clearing and settlement activity on January 20, 2024.**
- The scheduled switchover activity of shifting of CDSL's operations from Primary site to DR site and subsequent switchback activity on Saturday, January 20, 2024, is **Cancelled.**
- CDSL system will be available to users for execution of transactions on January 20, 2024, from Start of Day (SOD) of the said date till End of Day (EOD).
- **The timings of Early pay-in to avail margin benefit from CCs and collateral (margin pledge) shall be as on normal Trading and Clearing day with settlement holiday.**
- DPs will be allowed to enter Inter-Depository Transactions (IDT) for non-Government securities (non Gsec) from **SOD of the said business date till 09:30 pm.**
- DPs will be allowed to enter Inter-Depository Transactions (IDT) for Government securities (Gsec) from **SOD of the said business date till 05:00pm.**
- Rate Files will be available for the said trading date.
