DPs are advised to note that in terms of the Sovereign Gold Bond Scheme Procedural Guidelines issued by RBI vide circular RBI/2019-20/213 IDMD.CDD.2730/14.04.050/2019-20 dated April 13, 2020, premature redemption of bonds may be permitted after fifth year from the date of issue of such bond, on the date on which interest is payable.

Process to be followed for submission of the early redemption request by the client to the Participant is given below

1. The holders of bonds under the said ISIN's, who wish to participate in the early redemption option will be required to submit the Repurchase/Redemption Request Form (RRF) to the DP.
2. The DP shall execute and forward the early redemption request electronically under **Rematerialisation Module-Restat Option- Redemption** in the CDAS system.
3. Under the redemption option, the field for quantity is to be selected and the relevant quantity needs to be entered. **Please do not use the amount option.**
4. The DP shall provide the details of aforesaid request in the format enclosed at Annexure A in .xls format by e-mail (subject line of mail should be "**Early Redemption Request for SGB ISIN <ISIN Number>**") to [gsec@cdslindia.com](mailto:gsec@cdslindia.com)
5. DPs are advised to ensure the correctness of the bank details of the client in the demat account to avoid return of the redemption amount.
