TRADING WINDOW CLOSURE PERIOD FOR RESTRICTING TRADING BY DESIGNATED PERSONS (“DPS”) AND EXTENSION OF AUTOMATED IMPLEMENTATION OF TRADING WINDOW CLOSURE TO IMMEDIATE RELATIVES OF DPS OF ALL LISTED COMPANIES

Issuers / RTAs are advised to refer SEBI Circular nos. SEBI/HO/ISD/ISD-PoD-2/P/CIR/2023/124 dated July 19, 2023, SEBI/HO/ISD/ISD-PoD-2/P/CIR/2025/55 dated April 21, 2025, CDSL communique nos. CDSL/OPS/RTA/POLCY/2025/71 dated March 20, 2025 and CDSL/OPS/DP/POLCY/2025/165 dated June 17, 2025. These circulars / communiques are regarding Trading Window Closure (TWC) period under Clause 4 of Schedule B read with Regulation 9 of SEBI (Prohibition of Insider Trading) Regulations, 2015 (“PIT Regulations”) on Extending framework for restricting trading by Designated Persons (“DPs”) by freezing PAN at security level of all listed companies and Extension of automated implementation of trading window closure to Immediate Relatives of DPs.

Phase – 1 for Top 500 companies based on BSE market capitalization as of March 31, 2025, listed on BSE, NSE & MSEI from PAN-ISIN freezing start date July 01, 2025, is already implemented. Implementation of Phase – 2 i.e. for all the remaining companies listed on BSE, NSE & MSEI as well as companies that get registered on listed Stock Exchanges after issuance of said SEBI circular dated April 21, 2025, PAN-ISIN freezing will start date from October 01, 2025.

The operational guidelines for updating the TWC period are provided in Annexure - A:

In the view of above, all the issuers / RTAs are requested that the PAN, Promoters, Promoter Group, Directors etc. details of DP/s or Immediate Relatives should be updated regularly on DD portal for SAST and PIT regulations should be latest details. These details should be in line with the required criteria of SAST & PIT regulations. Issuers are requested to verify the updated data through their login credentials and immediately confirm that the said details are properly updated.

Issuers / RTAs are advised to take note of the same and ensure compliance.

Annexure - A

1. The automated TWC functionality is being activated for all listed Companies / Issuers to restrict trading by DPs on Stock Exchanges / Depositories.
2. The said functionality is currently extended to immediate relatives of DPs of all listed companies / equity ISINs.
3. The listed issuers who have appointed CDSL as their Designated Depository (DD) will be shown the menu “No Trading Window Period” in their issuer login on CDSL portal.
4. Issuer needs to assign below privileges to the user from his **admin login** to view the “No Trading Window Period” tab.
 - No Trading
 - No Trading Setup
 - No Trading Inquiry
 - Exemption Inquiry
5. Issuer needs to click on menu “No Trading Window Period” → Setup.
 - System display page with following details
 - Issuer ID – Pre-populated
 - ISIN – pre-populated
 - A trading restriction period shall be made applicable from the 1st business day of every quarter till 48 hours after the declaration of financial results for the previous quarter.
 - Freeze Start Date – Issuer needs to select the freeze start date (T Day) from date greater than 2 business days i.e., on T-2 days.
 - Freeze End Date – Date should be always greater than Freeze Start Date i.e., T+ n... days). The Issuer can select a notional freeze end date initially and modify it immediately after finalization of the confirmed date of their board meeting.
 - List of DP/s or Immediate Relatives already uploaded by the issuer for the purpose of System Driven Disclosure (SDD) will be displayed along with pre-populated Freeze Start date and Freeze end date as entered in the date fields above.
 - Issuer has to verify the data, include the details of DPs or Immediate Relatives and click on Submit button to confirm the BO – ISIN level freeze for debit and credit to be applied.
6. Once the details are submitted by issuer to the DD, system will identify the demat accounts of DP/s or Immediate Relatives based on the PAN of sole / joint holders entered by Issuer and freeze for debit and credit at BO – ISIN level in the identified demat account/s on Start of Day (SOD) of freeze start date.
7. The Demat accounts, where first holder PAN is of non-DP or Immediate Relatives, but the joint holder PAN is of the DP or Immediate Relatives, still the specific ISIN in identified demat account will be frozen for both i.e. debit and credit at BO-ISIN level.

8. The freeze reason code no. "25" with reason description "Trading Window Closure Period" will be used for the said BO-ISIN level freeze applied in CDSL systems.
9. During the freeze period, no debit or credit will be allowed in the demat account of the DP/s or Immediate Relatives for the specified ISIN as stated in point nos. 7 & 8 above.
10. Issuers need to inform their DPs or Immediate Relatives / joint holders accordingly.
11. Any trades done prior to "No trading window period" should be settled by way of giving early payin instruction in favor of their CM on the trade date i.e. T Day itself. DP/s need to give early / normal pay-in instruction on the trade date itself, to settle the trade obligation and avoid the shares being auctioned.
12. In case of any exemptions provided to be allowed to DP or Immediate Relatives during TWC period, the DP / BOs & Issuer need to update the exemption details in the system.
13. Any exemptions provided to DP/s or Immediate Relatives by the Issuer, during "No Trading Window Period" needs to be entered in CDSL system through the Issuer login minimum 2 days (T-2 days) prior to the exemption start date along with the proper reason (As per SEBI circular) for providing exemption.
14. Demat accounts of DP/s or Immediate Relatives who are provided with exemptions will be unfrozen on SOD of exemption start date and will be again frozen on the End of Day (EOD) of exemption end date. The settlement process as mentioned in point no. 11 needs to be followed.
15. For the second time exemption during the same TWC period, the TWC exemption end date should be 2 days after the previous exempted trade date on Stock Exchange/s.

→ Steps to update Immediate Relatives' data in portal: -

1. The **data updation process** remains unchanged from the previous procedure, with no modifications required in the portal. However, two additional columns have been introduced.

→ Additional Columns:

- **PAN of Related KMP**
- **Relation**

2. And the Relation can be defined as: 0- Others, 1- Mother, 2- Father, 3- Spouse, 4- Son and 5- Daughter.

Help for the Values in the Data :

1. For a CEO, Director, Employees, Promoter, Promoter Group and Other Designated Person, PAN is to be provided. In case of PAN exempt cases, BO ID details should be provided.
2. Foreign Nationals who are Promoters / directors / Designated Persons in listed companies and do not have PAN or Demat Account, companies need not provide their details. As and when the Foreign Promoters / directors / Designated person obtain PAN, the company may provide the details to CDSL.
3. Effective date (YYYYMMDD) is the date on which CDSL would initiate monitoring. The column viz; Effective date should be in text format.
4. Category / Level (Director / Employee) can be defined as:
 1. For a CEO, Director and Employees, PAN is to be provided. In case of PAN exempt cases, BO ID details should be mandatory.
 2. Foreign Nationals who are directors in listed companies and do not have PAN, companies need not provide their details. As and when the foreign directors obtain PAN, the company may provide the details to CDSL.
 3. Effective date (YYYYMMDD) is the date on which CDSL would initiate monitoring. To start with the effective date would be 1-Aug-2018 as per SEBI circular dated 28th May 2018. The column viz; Effective date should be in text format.
 4. Category / Level (Director / Employee) can be defined as:
 - 1- Director
 - 2- CEO with Directorship
 - 3- CEO – without Directorship
 - 4- Employees upto two levels below CEO
 - 5- Promoter
 - 6- Promoter Group
 - 7- Other Designated Person
 - 8- Immediate Relative
 5. Relation can be defined as:
 - 0- Others
 - 1- Mother
 - 2- Father
 - 3- Spouse
 - 4- Son
 - 5- Daughter
